GOVERNMENT OF ASSAM ORDERS BY THE GOVERNOR OFFICE OF THE GUWAHATI METROPOLITAN DEVELOPMENT AUTHORITY

NOTIFICATION

The 23rd October, 2017

No. GMDA/GEN/13/2009/150.- Whereas GMDA with prior approval from Government of Assam proposed to make certain modifications in the Final Master Plan and Zoning Regulation 2025 of Guwahati for entire area North of Brahmaputra covering North Guwahati Area, Scheme Area I and II notified vide no. GMDA/GEN/13/2009/67 Dated 30th July, 2010 in the Assam Gazette Extraordinary No. 230 dated 31st July 2010 pertaining to certain land allotted by Government to institutions like AIIMS/Central & State Govt. establishment as mentioned and notified in draft notification No. GMDA/GEN/13/2009/101 dated 10/03/2017 inviting objections/suggestions as required under Sub-section (3) of Section 22 of the GMDA Act 1985 (amended) with one month from the date of issue of draft notification.

Whereas, it was observed that in the details of the Draft Modification the "Dag No. 390 (O)/2635 (N)" was inadvertently mentioned as "Dag No. 392" and hence a corrigendum was issued vide No. GMDA/GEN/13/2009/109 dated 20/05/2017 correcting the aforesaid typographical error allowing another one month time from the date of the said corrigendum for public objection/suggestion.

Whereas, State Government after carefully considering all aspects of the matter has directed Authority to modify the Master Plan pertaining to these lands allotted by State Government to institutions/Central & State Govt. establishment details of which is given below and directed GMDA to modify the Master Plan observing all necessary provisions of the GMDA Act 1985 (amended).

Whereas, the objections/suggestions received in regard to proposed modification has been heard by the GMDA and disposed of.

Now, therefore, in exercise of the powers conferred by Sub-section (1) of Section 22 of the GMDA Act and as per the approval of State Government vide order GDD.223/2017/33 dated 23/10/2017 the following final modifications in the said Master Plan & Zoning Regulation has been carried out as deemed fit by this Authority and is published under Sub-section (4) of Section 22 of the GMDA Act. This will come into effect from the date of publication of this notification.
