**PUBLIC NOTICE**

It has been observed that a large numbers of Ware Houses, and Truck Parking Yards along with Coal Stacking Yards have come up along the NH-27 on both the sides of the Highway from the Khanapara to Jalukbari Point. As the City is expanding towards the highway, the unabated construction of the Ware Houses, Truck Parking Yards along with Coal Stacking Yards are now conflicting with the present development and contributing to pollution, traffic congestions and posing as hazards to the entire stretch of National Highway. Further these uses are also threatening the Eco Sensitive Zone located in Páschim Bora Gaon containing the Eco System of Dipar Bill.

In view of the above, all concerned public are hereby notified to shift all the Ware Houses, Truck Parking Yards and Coal Stacking Yards to area outside the purview of the Master Plan for Guwahati Metropolitan Area - 2025 published vide notification no. GMDA/MP/1/98/Part-I/103 dated 07/07/2009 within 6 (Six) months from the date of publication of this notice.

GMDA shall carry out interim amendments/modifications of the relevant provisions of the Master Plan as per the GMDA Act, 1985 for shifting the uses as mentioned above.


