The scope of the services will be preparation of the for Concept Paper/Project proposal/DPR/ Drawings & Designs etc. for various development works undertaken by the authority for estimated project value not exceeding Rs. 10.00 crores or any other value at the discretion of the authority.
2. You are advised that under no circumstances, you should use any legend containing the GMDA's name or symbol on your letter heads, signboards, name plates, visiting cards etc. You will not use this empanelment to canvas for your business.
3. The empanelment does mean the guarantee of awarding of work. The allotment of work to the empanelled firm will be at the sole discretion of authority. The work shall be assigned either at a rate not exceeding the rate of APWD or at competitive rate. The Authority is free to use the services of any Architect/Engineering Consultant firm of its choice and no right exists for and empanelled Architect/Engineering Consultant firm to claim that they alone should be entrusted with GMDA's work.
4. The empanelment is valid up to 31<sup>st</sup> March, 2018. However, GMDA has right to remove you from empanelment without assigning any reason during the empanelment period.
5. Every report should also contain a declaration certificate that you have not been dismissed or removed from Govt. Service or convicted of an offence connected with any proceeding of Income Tax Act, Wealth Tax Act. Or Gift Tax Act or have been blacklisted by any Govt. Department/Public Sector Enterprise.
