NOTIFICATION

- 1. Whereas certain modifications which the GMDA proposed to make with approval of State Government in the Master Plan for Guwahati 2025 as part of review and subsequent modifications which were notified vide no. GMDA/GEN/69/2019/74 dated 12.03.2020 by GMDA in accordance with provision of Section (22) of the GMDA Act 1985 (as amended) inviting objection/suggestion as required by Sub Section (3) of Section 22 of the said Act within one month from the date of issue of the notification.
- 2. Whereas, objections/suggestions received with regard to the proposed modifications have been carefully considered by Guwahati Metropolitan Development Authority.
- 3. Whereas, State Govt. after carefully considering all aspects of the matter has decided to modify the Master Plan for Guwahati Metropolitan Area pertaining to allowing only the setting up of Army Institute of Nursing in village no.2 Kahilipara on a plot of settled land in Eco-friendly Zone of Guwahati Master Plan, 2025 and requested GMDA vide letter no. GDD.384/2019/254 dated 05/06/2021 for amending the relevant portion as per provisions of the GMDA Act 1985 (as amended).
- 4. Now therefore, in exercise of powers conferred by Sub-section (1) of Section (22) of GMDA Act 1985 (as amended), GMDA hereby makes the following modifications in the Master Plan and Zoning Regulation for Guwahati 2025 as per approval of State Government vide letter No.GDD.142/2021/56 dated 01/07/2021 and as described in the Schedule of modification below.
