NOTIFICATION

In exercise of the power conferred by Section 7 of Guwahati Waterbodies (Preservation and Conservation) Act, 2005, the Guwahati Metropolitan Development Authority (GMDA), on receipt of permission from the State Government vide letter number Ecf No. 449213 dated 17/02/2024 has resolved to take up project for better management, preservation and conservation of the water body falling under Schedule-IV (Near Deepor Beel) of the Guwahati Waterbodies (Preservation and Conservation) Act, 2008 (the Act).

Whereas, under the provisions of the Assam State Policy for grant of Transferable Development Rights (TDR) notified by the Government vide notification No. UDD(T)/270/2022/26 dated 28/09/2022, GMDA intends to issue Transferable Development Rights (TDR) to the Owners of all Patta lands falling under Schedule –IV of the Guwahati Waterbodies (Preservation and Conservation) Act, 2008 where restriction under Section 4 of the Act is applicable.

Pursuant to thereto, GMDA vide this notice is inviting applications from the owners of all land falling within the area under Schedule –IV of the Guwahati Waterbodies (Preservation and Conservation) Act, 2008, who intends to avail the benefit of Transferable Development Rights (TDR). Applications for grant of TDR may be submitted to GMDA within a period of 30 (Thirty) days from the date of publication of this notification. The application forms for availing TDR may be obtained from the official website of GMDA (www.gmda.assam.gov.in). For details on grant of TDR, the owners may also contact the office of the GMDA at Statfed Building, Bhangagarh, Guwahati-781005 during office working hours.
