 - Supply of all equipment as per Technical Specifications.
 - Port & custom clearance of imported machinery, if any.
 - Payment of Excise duty, Insurance charges, Octroi, Works Contract Tax, Sales Tax, or any other tax on any account in terms of clauses 37 of General Conditions of Contract.
 - Custom duty or other Govt. levy in custom department (other than due to default of contractor) to be paid shall be reimbursed as per actual.
 - Transportation of machinery upto site.
 - Civil works at site.
 - Erection & commissioning of imported/Indian equipment, if any.
 - Training of owner's personnel at site, if required.
 - Preparation of detail structural drawing and vetting the structural drawing from Government institution like IIT, NIT, AEC, JEC, etc. or expert Consultant as recommended by GMDA.
