# SUMMARY OF DISCUSSION AND RESPONSE TO QUERIES OF THE PRE- BID MEETING

**Subject: Pre-bid meeting for "**Selection of Project Management Consultant (PMC) to Design, Develop, Manage and Implement Smart City Projects (SPV/GSCDAL/GEN/2/2016/07)".

The Pre-bid meeting was held on 12th August2016 as per the schedule notified in the RFP at Office of GSCDAL, Statfed Building, Bhangagarh, Guwahati, Assam-781005. The list of representatives of the prospective bidders attended the meeting is Annexed.
