- c. EOI will be evaluated for short listing inter alia based on their past experience of handling similar type of project, strength of their man power, financial strength of firm.
- d. Short listed agencies will be issued Bid Documents and asked to submit their price proposal in a sealed envelope.

Applicants are encouraged to submit their respective proposals after visiting the sites and ascertaining for themselves the site conditions, traffic, location, surroundings, access to the site, site work, availability of drawings and other data with the Authority, Applicable Laws and regulations or any other matter considered relevant by them.

The Application must remain valid for a period of not less than 90 days after the Application Due Date (the “ADD”). The Authority will endeavour to complete the scrutiny and evaluation of the received Applications and select the bidder within this period.
