#### TERMS AND CONDITIONS

## "OPERATE THE RESTAURANT IN SHRADDHANJALI KANAN"

- 1. The contract period is for one year from the date of agreement extended for another 2 years on satisfactory performance and mutually agreed terms and conditions.
- 2. The monthly rent is to be paid by the party monthly to GMDA on or before the 10<sup>th</sup> day of each current English calendar Month.
- 3. Minimum base lease amount of the restaurant is Rs-50,000/- per month.
- 4. Party has to deposit a refundable security money of three times of monthly rent to GMDA within 7 (seven) days of signing of Agreement. No interest will be payable for the Security Deposit. Security money shall be refunded on the expiry of the agreement or termination of the agreement.
- 5. The party shall at its own cost install an electric meter in the restaurant in the name of GMDA and the dues and levis for consumption of electricity of the restaurant during the period of subsistence of the agreement shall be regularly and wholly be paid by the party to APDCL as per bill.
- 6. All expenses arising in connection with repairs of the structure of the restaurant including equipments and fixtures installed therein, furniture, colour washing/painting, maintenance shall be borne by the party. However, major structural damage due to natural decay will be taken care of GMDA.
- 7. Cooking of food by using LPG stove, use of microwave, oven for heating of pre cooked food, use of Refrigerator will be allowed. However use of fire wood, coal are strictly prohibited
- 8. Party shall maintain the restaurant to a high degree of decency and aesthetics and enforce all discipline in the restaurant and its staff and management.
- 9. Party shall not store any contraband material which is prohibited by law. Park is a tobacco free zone. No alcoholic/tobacco product shall be allowed to be sold in the restaurant.
- 10. Food sold will have to adhere to the food of safety regulatory laws in force.
- 11. Waste disposal as per pollution control norms has to be adhered to and waste disposal arrangement is to be incorporated in the offer proposal.
- 12. Total number of employees engaged in the restaurant is restricted upto 8 (eight) employees & uniform is to be worn by the employees during work. The Manager and employees is to be a skilled & experienced person in hospitality sector and having good personality. Certificate of cook is required.
- 13. Party shall not be entitled to sell any other products in the restaurant other than the products approved by the GMDA.
- 14. The menu of items to be sold is to be submitted with the proposal which will form a criteria for
