1. INTRODUCTION

It is proposed to set up a **GIS-based GEoHUB** for the Department of Housing and Urban Affairs, with a wide variety of urban features and analytical tools for creating a repository of critical urban data and information of urban areas of Assam. For it is proposed to set up a GIS web-based portal for the GEOHUB for Department of Housing and Urban Affairs under Guwahati Metropolitan Development Authority (GMDA) as the Implementing Authority.

2. SCOPE OF WORK

GMDA seeks proposals from qualified communication service providers for Internet Service Provider (ISP) to implement Internet leased line on fiber connectivity as per below mentioned specifications:

- a. Requirement of 20 MBPS Bandwidth Internet Leased Line on Fiber
- b. Bandwidth with 1:1 uplink & downlink ratio
- c. LAN Ports 15 Nos.
- d. Router Specs: DRAM : 4 GB

Flash: 4 GB Multicore Processor Integrated Gigabit Ethernet Ports Optional PoE Upgrade

- e. Service availability of >98%
- f. Provider to ensure Inclusion of active, passive components, network infrastructure for the service delivery
- g. Maintenance services 24*7*365
- h. Preferred ISP's: Airtel, Jio, Vi Internet Leased Lines (Vodafone), MNET, etc

As a part of Evaluation of proposals submitted by the applicants, GMDA reserves the right to seek further information from the Organizations for evaluation purposes. GMDA may call for such information at a short notice.

6. TIMELINE

One-year Contract and renewal subject to satisfactory performance.

7. AMENDMENTS TO RFP

At any time prior to the last date for receipt of applications, GMDA may for any reason, whether at its own initiative or in response to a clarification requested by a prospective applicant, modify the RFP document by an amendment. In order to provide prospective applicants reasonable time in which to take the amendment into account in preparing their proposals, GMDA may at its discretion extend the last date for the receipt of proposals and/or make other changes in the requirements set out in the RFP.

8. REJECTION OF APPLICATION

The application is liable to be rejected if:

- a. Not in prescribed forms and not containing all required details.
- b. Not properly sealed and signed as per requirements.
- c. Received after the expiry of due date and time.
- d. Missing of any supporting document(s) with the Proposal.

9. DISCLAIMER

- a. The GMDA shall not be responsible for any late receipt of applications for any reasons whatsoever. The applications received late will not be considered and returned unopened to the applicant.
- b. The GMDA reserves the right
 - i. To reject any/all applications without assigning any reasons thereof.
 - ii. To relax or waive any of the conditions stipulated in this document as deemed necessary in the best interest of the GMDA without assigning any reasons thereof.
 - iii. To include any other item in the Scope of work at any time after consultation with applicants or otherwise

10. NO SUBLETTING ASSIGNMENT

There must be no further subcontracting without prior written consent of GMDA.

11. MAINTENANCE OF CONFIDENTIALITY

The agency must not divulge any confidential information and assure that reasonable steps are taken to provide for the safe custody of any and confidential information in its possession and to prevent unauthorized access thereto or use thereof. The agency must not, without the prior written consent of GMDA, disclose any confidential information of GMDA or any government department or relating to any ministry or any other party. In giving written consent to the disclosure of confidential information, GMDA may impose such conditions as it thinks fit, and the agency must comply with these conditions. Confidentiality clause shall survive for a longer period of one year after the termination of contract or contract expiry period.

12. TERMINATION OF CONTRACT

e. Termination for Default

GMDA reserves the right to terminate / short close the contract, without prejudice to any other remedy for breach of contract, by giving one month notice if the agency fails to perform any obligation(s) under the contract and if agency, does not cure their failure within a period of 04 days (or such longer period as GMDA may authorize in writing) after receipt of the default notice from GMDA.

f. Termination for Insolvency

GMDA may at any time terminate the contract by giving written notice without compensation to the agency, if the agency becomes bankrupt or otherwise insolvent, provided that such termination will not prejudice or affect any right of action or remedy which has accrued or will accrue thereafter to GMDA.

g. Termination for Convenience

GMDA may by written notice sent to agency, terminate the contract, in whole or part, at any time for its convenience. However, the payment shall be released to the extent to which performance of work executed as determined by agency till the date upon which such termination becomes effective.

13. FORCE MAJEURE

Neither party shall be held responsible for non-fulfilment of their respective obligations due to the exigency of one or more of the force majeure events such as but not limited to Acts of God, war, flood, earthquakes, strike, lockouts, epidemics, riots, civil commotion etc., provided on the occurrence and cessation of any such events. The affected party thereby shall give a notice in writing to the other party within one week of such occurrence or cessation. If the force majeure conditions continue beyond six months the parties shall then mutually decide about the future course of action.
