CONDITIONS OF CONTRACT

1. The bidders have satisfactorily completed similar type of work i.e., Dismantling / Demolition, Sealing of Building / Civil Structure or Civil Works during the last three years.
2. The Buildings as referred shall be dismantled and all the rubbish shall be removed after taking away the unused materials on "as is where is basis". The bidder has to ensure that the surrounding / adjoining structures are not damaged during the dismantling work. The Site shall be levelled to the satisfaction of the engineer.
3. The demolition shall be executed in daytime only in presence of GMDA officials with proper security forces.
4. The Authority will not be liable to pay any compensation for any accident, injury to the contractor's work men or on any account what-so-ever.
5. The contractor has to comply with the norms of IS 4130:1991 Indian Standard Demolition of Buildings -Code of Safety (Second Revision) while executing the work.
6. The Contractor shall take adequate precautions and safety measures while demolishing the existing Building so as not to cause any damage to adjacent building, road, water mains, and electric overhead lines/underground cables etc. The road foot path and the lines around the plot shall be kept clear for the use of vehicle/pedestrians. The materials etc. shall not be stacked on roads/paths. Any damage in this regard shall have to be made good by the tenderer/bidder at his own risk and cost. Fine if imposed for damage/encroachment/ obstruction shall be borne by the contractor.
7. The tender documents shall be accompanied by a lump sum earnest money of Rs. 25000/- (Twenty-Five Thousand rupees) in the form of DD/Cash deposit/IPO in favour of CEO, GMDA.
8. The tenderer/bidder whose tender/bid is accepted shall deposit a security amounting to Rs.1.00 Lakh (One Lakh Rupees) within 7 days of the award of the work/issue of work order.

9. The earnest money of successful tenderers shall be adjusted with the security deposit. The earnest money of other unsuccessful tenderer shall be released.
10. While quoting the rates the tenderer/bidder shall take into account all the factors mentioned above. Nothing extra shall be payable for any of these operations.
11. No sale of dismantled material shall be permitted from the site and all such material shall have to be removed from the site within 2 (two) days of dismantling.
12. The area should be barricaded or cordoned off by suitable means to avoid mishaps of any kind. Proper warning signs should be displayed for the safety of the public whenever demolition and clearing works are undertaken.
13. These safety provisions should be brought to the notice of all concerned by display a notice board at a prominent place at work spot.
14. To ensure effective enforcement of the rules and regulations relating to safety precautions, the arrangements made by the contractor shall be open to inspection by the Engineer-in-Charge of GMDA.
15. The vehicles used in the work by the contractor should have all necessary and upto-date paper as per Govt. rule.
